To all to whom these presents shall come Greeting,  
 Whereas John Koehreiter of Buffalo County Nebraska has  
 deposited in the General Land office of the United States a Certificate  
 of the Register of the Land office at Grand Island Nebraska  
 whereby it appears that full payment has been made by the said  
 John Koehreiter according to the provisions of the Act of  
 Congress of the 24th of April 1820 entitled "An act making further  
 provisions for the sale of Public Lands," and the acts supplemental  
 thereto for the North East Quarter of section one in Township  
 Twelve North of Range Seventeen West of the Sixth Principal  
 Meridian in Nebraska containing one hundred and sixty  
 acres and twenty four hundredths of an acre according to the  
 official Plat of the Survey of the said Lands, returned to the General  
 Land office by the Surveyor General, which said tract has  
 been purchased by the said John Koehreiter.

Now Know ye that the United States of America, in consideration  
 of the premises, and in conformity with the several acts of Congress  
 in such cases made and provided have given and granted, and  
 by these presents do give and grant, unto the said John Koeh-  
 reiter and to his heirs the said tract above described,  
 to have and to hold the same together with all the rights privileges  
 immunities and appurtenances of whatsoever nature thereunto  
 relating unto the said John Koehreiter and to his heirs  
 and assigns forever.

In Testimony Whereof I Benjamin Harrison President  
 of the United States of America, have caused these letters to be  
 made Patent, and the seal of the General Land office to be  
 hereunto affixed.
