Neal has been established and duly consummated, in conformity to law, for the East Half of the North-East Quarter of Section Thirty-two in Township Nine, North of Range seventeen West of the Sixth Principal Meridian in Nebraska, containing Eighty acres according to the Official Plat of the survey of the said Land, returned to the General Land Office by the Surveyor General:
