BUFFALO COUNTY, NEBRASKA

Notice is hereby given that on Tuesday the 3rd day of November 2026 at the polling places in the election precincts of Buffalo County, Nebraska; a General Election will be held. You can find your polling location by using the Nebraska Voter Check website at: <https://www.votercheck.necvr.ne.gov/VoterView>. The polls will open at 8 a.m. CDT and close at 8 p.m. CDT. Said election will be for electing candidates to various offices and for such issues as stated. Some races will not appear on your General Election ballot as the candidates are elected by specific subdivisions, districts or wards. The Secretary of State will publish a true copy of the title and text of any amendment or referendums once a week for three consecutive weeks preceding the election.
