RESOLUTION 2023-26

WHEREAS, Mitch Humphrey, licensed land surveyor, on behalf of Diane Carlson, hereinafter referred to as "applicant", has filed for an Administrative Subdivision to be known as "Diane Carlson Administrative Subdivision", with the Buffalo County Clerk and/or Zoning Administrator, and

WHEREAS, the Zoning Administrator forwarded this application to this Board, and

WHEREAS, on April 25, 2023, this Board conducted a public hearing now and finds:

- 1. The proposed "Diane Carlson Administrative Subdivision" is in the Agricultural Residential (AGR) Zoning District for Buffalo County, Nebraska.
- 2.
