## **RESOLUTION 2023-30**

WHEREAS, on March 3, 2023, Michael Mauslein, Owner and Operator of Mauslein Land Holdings, L.L.C., has applied for a Zoning Map Amendment with the Buffalo County Zoning Administrator, requesting that the following real estate property, hereinafter referred to as the "subject property", to wit:

A tract of land being part of the Northeast Quarter of the Northwest Quarter and part of Government Lot One (1) located in Section Thirty (30), Township Nine (9) North, Range Fourteen (14) West of the 6<sup>th</sup> P.M., Buffalo County, Nebraska, more particularly described as follows: Referring to the Northwest Corner of Government Lot 1 in Section 30 and assuming the West line of Government Lot 1 as

A distance of 150.66 feet to the Southeasterly corner of said tract of land, said point also being on the North line of the Union Pacific Railroad Company's Right-of-Way; thence N73°30'E and on the North line of the Union Pacific Railroad Company's Right-of-Way, a distance of 317.08 feet; thence continuing N73°30'E and on the North line of the Union Pacific Railroad Company's Right-of-Way, a distance of 317.08 feet; thence leaving the North line of the Union Pacific Railroad Company's Right-of-Way, N04°30'W a distance of 313.50 feet; thence continuing on the aforedescribed course N04°30'W a distance of 11.73 feet; thence N89°29'20"W and parallel with the North line of said Government Lot 1, a distance of 373.17 feet; thence S00°09'34"W and parallel with the West line of said Government Lot 1, a distance of 96.91 feet; thence S16°29'55"E a distance of 334.45 feet to the place of beginning.

Containing 3.05 acres more or less, hereinafter referred to as "subject property", be changed from the Agriculture (AG) District to the Industrial (I) District. The property is in the name of Mauslein Land Holdings, L.L.C.

WHEREAS, this is solely a zoning map amendment request and the subject property would or could have other land use regulations that would apply to it above and beyond the zoning map amendment sought at this meeting, and

WHEREAS, on April 20, 2023, the Buffalo County Planning and Zoning Commission, following public hearing with notice as required, recommended approval of such proposed change in zoning on an 8-0 vote with one absence and no abstentions, and

WHEREAS, on May 23, 2023, this Board conducted a public hearing and considered this Zoning Map Amendment, the minutes of the Planning and Zoning Commission considering this amendment, Buffalo County Zoning Regulations, and Comprehensive Plan, and finds:

- a. No letters of opposition against the amendment.
- b. That such change in zoning designation would have minimal adverse effect on surrounding properties.
- c. That the intended uses of the Industrial (I) District are consistent with property use in the surrounding area.
- d. This amendment is consistent with the growth and development of Buffalo County and the overall Comprehensive Plan adopted by Buffalo County, Nebraska, and
- e. The subject property is situated close to already existing public improvements, such as sufficient utilities and an all-weather road, so that the map amendment with its attendant changes in uses will not cause additional public costs to function effectively.

WHEREAS, no protest (s) against such amendment have been filed with the Buffalo County Clerk within seven days of conclusion of public hearing of such Commission as allowed under Section 11.4, and

WHEREAS, the votes in favor of adoption of this resolution need only be by majority of members to this Board of Commissioners.

NOW THEREFORE, BE IT RESOLVED BY THE BUFFALO COUNTY BOARD OF COMMISSIONERS that application for zoning map amendment to change the subject property from the Agriculture (AG) District to Industrial (I) District is approved, and

BE IT FURTHER RESOLVED that a copy of this Resolution shall be filed in the Register of Deed's office against subject property and any parcel situated partially or entirely within such legal description, and that the County Clerk shall make amendment to Buffalo County Zoning District Map originally adopted on or about September 10, 2002.

Paul Brune of Nebraska Public Power District, Shelby Mayash ROW Agent HDR, Todd Muehlich ROW Agent, HDR, Ryan Dykes Survey Project Lead, Westwood were present for the presentation for an update on the Kearney 115kV transmission line project. A copy of the handout will be filed with the County Clerk.

Chairperson Klein opened the public hearing at 9:31 A.M. for new applications for a retail liquor license (Class C License) and a manager's application by The Ridge, L.L. C. dba Buffalo Ridge Golf Course located at 7335 N Ave, Kearney, Nebraska. James Wiltgen was present to introduce himself to the Board. When Chairperson Klein asked if anyone was for the Liquor License request, 5 community members in attendance raised their hands in agreeance, no one was opposed. No one else addressed the Board and Chairperson Klein closed the public hearing at 9:33 A.M. After review of the County Sheriff's office report, it was moved by Maendele and seconded by Kouba to approve the request for a Class C Liquor License and manager's application. Upon roll call vote, the following Board members voted "Aye": Maendele, Kouba, Higgins, Loeffelholz, Lynch, Morrow and Klein. Motion declared carried.

Jeff Laubach, P.E., from SBB Engineering L.L.C., spoke with the Board regarding his request to proceed with a contract for road improvement. Highway Superintendent John Maul and Deputy County Attorney Hoffmeister were available for questions following discussion. Moved by Morrow and seconded by Lynch to acknowledge receipt of request and enter into negotiations for the preparation of contract for road improvement. Upon roll call vote, the following Board members voted "Aye": Morrow, Lynch, Higgins, Kouba, Loeffelholz, Maendele and Klein. Motion declared carried.

## ROAD DEPARTMENT

Highway Superintendent John Maul was present for the following agenda items.

The Board reviewed the report of the Buffalo County Highway Superintendent regarding the Petition to close a portion of a road situated in Glenwood Estates Subdivision which was received by the Board in the May 9, 2023 meeting. The Superintendent recommended that the Board close this road and also noted that the road that is petitioned to be closed is situated entirely within the zoning jurisdiction of the City of Kearney, a City of the First Class as defined by state law. Therefore, pursuant to state law, the county must have permission of the Class 1 City prior to proceeding with hearing on the vacation issue. Therefore it was moved by Lynch seconded by Higgins to accept Highway Superintendent Maul's report and that a copy of these minutes, a copy of the petition to close, and the Highway Superintendent's report be forwarded by the County Clerk to the City Clerk of the City of Kearney, for the purposes of obtaining the City of Kearney's permission to close this road, and that any public hearing of this Board regarding the pending petition to close this road be delayed until the City of Kearney grants permission to close this road. Upon roll call vote, the following Board members voted "Aye": Lynch, Higgins, Kouba, Loeffelholz, Maendele, Morrow and Klein. Motion declared carried.

Moved by Maendele and seconded by Kouba to have Chairperson Klein sign on behalf of Buffalo County the Agreement for the Provision of Limited Professional Services for the 2024 Asphalt Concrete Pavement Projects between Buffalo County and Miller and Associates Consulting Engineers. Upon roll call vote, the following Board members voted "Aye": Maendele, Kouba, Higgins, Loeffelholz, Lynch, Morrow and Klein. Motion declared carried.

Moved by Loeffelholz and seconded by Higgins to purchase a JCB Model 3TS-8T Teleskid (Skid Loader) with wide rubber track and GP Bucket. Total price \$108,929.97 less trade in of \$18,000.00 on 210 New Holland L180 Skid Steer Loader S/N NAM417737. Total purchase price of \$96,754.16. This is through Sourcewell Contract #040319-JCB. Upon roll call vote, the following Board members voted "Aye": Loeffelholz, Higgins, Kouba, Lynch, Maendele, Morrow and Klein. Motion declared carried.

Chairperson Klein opened the public hearing for the 2023-2024 One and Six Year Road and Bridge Plan at 10:00A.M. Highway Superintendent Maul was present for discussion and review. No one else addressed the Board and Chairperson Klein closed the hearing at 10:07A.M. Moved by Lynch and seconded by Loeffelholz to adopt the One and Six Year Road and Bridge Program for 2023-2024 as presented. Upon roll call vote, the following Board members voted "Aye": Lynch, Loeffelholz, Higgins, Kouba, Maendele, Morrow and Klein. Motion declared carried.

Moved by Loeffelholz and seconded by Higgins to set bid date of Tuesday, June 13, 2023 at 10:00 A.M. for Project No. C10 (1008) Kilgore Road starting at Lowell Road going west for three miles. Project consists of adding 1 foot of clay/dirt on road top. Upon roll call vote, the following Board members voted "Aye": Loeffelholz, Higgins, Kouba, Lynch, Maendele, Morrow and Klein. Motion declared carried.
