RESLOUTION 2024-53

WHEREAS, Jeremy Feusner, licensed land surveyor, on behalf of Kimberli D. Dawson, Manager of LKDAW, L.L.C., hereinafter referred to as "applicant", has filed for an Administrative Subdivision to be known as "White Acres Administrative Subdivision", with the Buffalo County Clerk and/or Zoning Administrator, and

WHEREAS, the Zoning Administrator forwarded this application to this Board, and

WHEREAS, on December 10, 2024, this Board conducted a public hearing now and finds:

- 1. The proposed "White Acres Administrative Subdivision" is in the Agricultural (AG) Zoning District for Buffalo County, Nebraska.
- 2. The remaining portion of the subdivided tract, presently owned by LKDAW, L.L.C., situated in part of the North Half of Section Thirty-One (31), Township Nine (9) North, Range Eighteen (18) West of the Sixth Principal Meridian, Buffalo County, Nebraska, complies with the minimum lot size of this zoning district; any remnant property not subdivided and owned by LKDAW, L.L.C., amounts to roughly 318 acres.
- 3. The proposed plat for this subdivision fulfills Buffalo County's Subdivision Resolution requirements for administrative subdivisions specifically allowed under Section 3.02, together with other provisions applicable, thereto.
