1. The 2025-2026 property tax request be set at:

- 2. The total assessed value of property differs from last year's total assessed value by 11.54%
- 3. The tax rate which would levy the same amount of property taxes as last year, when multiplied by the total assessed value of property, would be \$.300782 per \$100 assessed value
- 4. The County proposes to adopt a property tax request that will cause a tax rate to be \$.322408 per \$100 of assessed value

With the passing of new legislation LB376, DHHS is asking the County how they wish to proceed.
