Chairman Pierce reviewed the following correspondence with the Board. Mike Baldwin, former Deputy County Public Defender, sent a thank you note. Invitation to the Treasure Central Nebraska Children event was received. Ron Grapes sent correspondence in reference to the Ft Kearny Shooting Sports Association. City of Kearney sent an updated City Limits Map and information regarding the Backflow preventers for 1512 Central Avenue. FEMA Map Service Center sent information on the National Flood Insurance Program. Moody's Investors Service sent the Buffalo County Bond rating. NIRMA sent out schedule of the Self Defense Course and the Quarterly Loss Reports. UNL Extension Educator sent the Buffalo County Extension Board report. Newsletters from Nebraska Farm Service Agency, USDA Farm Service Agency, Sterling Education Service Inc., and Epworth Village were received. Chairman Pierce then called on each Board member for the various committee reports and recommendations.

Tom Sheldon, owner of Jammers located at the Odessa exit of I-80, made a request to extend the closing time for hours of operation to sell alcoholic beverages. State law changed on July 14, 2010 which says that this Board must pass an ordinance or resolution to allow/disallow the extension of closing times within this Boards jurisdiction. After discussion, it was moved by Loewenstein and seconded by Dannehl to set a public hearing date of August 24, 2010 at 10:30 A.M. for public input regarding the possible change of available hours to sell alcoholic beverages at establishments that fall under the jurisdiction of Buffalo County. ## **RESOLUTION 2010-43**

WHEREAS the use of illegal and prescription drugs and the abuse of alcohol and nicotine constitute the greatest threats to the well-being of America's children:

WHEREAS 15 years of surveys conducted by The National Center on Addiction and Substance Abuse (CASA) at Columbia University have consistently found that the more often children and teenagers eat dinner with their families the less likely they are to smoke, drink and use illegal drugs;

WHEREAS frequent family dining is associated with lower rates of teen smoking, drinking, illegal drug use and prescription drug abuse;

WHEREAS the correlation between frequent family dinners and reduced risk for teen substance abuse is well documented;

WHEREAS parents who are engaged in their children's lives – through such activities as frequent family dinners – are less likely to have children who abuse substances;

WHEREAS family dinners have long constituted a substantial pillar of family life in America:

NOW, THEREFORE, We, The Buffalo County Board of Supervisors, do hereby proclaim the fourth Monday of September as *Family Day- A Day to Eat Dinner with Your Children* and urge all citizens to recognize and participate in its observance.
