Deputy County Attorney Melodie Bellamy, Zoning Administrator Leann Klein and Mitchell Humphrey were present. Deputy County Attorney Bellamy stated that the application was reviewed by Deputy County Attorney Hoffmeister and presented the draft resolution. RESOLUTION 2010-62

WHEREAS, Mitchell W. Humphrey, surveyor on behalf of Josiah H. Woodward, a married man, hereinafter referred to as "applicants" have filed for an administrative Subdivision to be known as "Sunset Hills Administrative Subdivision" with the Buffalo County Clerk and/or Zoning Administrator, and

WHEREAS, on the Zoning Administrator forwarded this application to this Board, and

WHEREAS, on October 12, 2010, this Board conducted a public hearing and finds:

- 1. The proposed Sunset Hills Administrative Subdivision" is located in part of Government Lot Four (4) located in Section Eighteen (18), Township Nine (9) North, Range Sixteen (16), West of the Sixth P.M., Buffalo County, Nebraska and is in the Agricultural Residential (AGR) Zoning District for Buffalo County, Nebraska.
- 2. The proposed plat for this subdivision fulfills Buffalo County's Subdivision Resolution requirements for administrative subdivisions specifically allowed under Section 3.02 together with other provisions applicable thereto.
- 3. Eighty-fifth (85th) Street, a Buffalo County section line open public road, abuts the proposed subdivision. The width of this road after dedication complies with minimum width standards required by the Buffalo County Subdivision Resolution.
- 4. Title search paperwork has been provided to the Buffalo County Attorney's Office and that office has cleared title based upon the title search documents delivered to that office by applicants.
- 5. This proposed administrative subdivision should be approved.

NOW THEREFORE, BE IT RESOLVED BY THE BUFFALO COUNTY BOARD OF SUPERVISORS in regular session with a quorum present, that the plat of "SUNSET HILLS ADMINISTRATIVE SUBDIVISION", an administrative subdivision being in part of Government Lot Four (4) located in Section Eighteen (18), Township Nine (9) North, Range Sixteen (16), West of the Sixth P.M., Buffalo County, Nebraska duly made out, acknowledged and certified, is hereby approved, accepted, ratified, and authorized to be filed and record in the Office of the Register of Deeds, Buffalo County, Nebraska.

Chairman Pierce opened the public hearing for administrative subdivision filed by Mitchell Humphrey on behalf of Roger and Patricia Standage for Standage Country Estate for property located in the E ½ of the SW ¼ of Section 24, Township 9 North, Range 17 West of the 6th p.m., Buffalo County, Nebraska. Lonty Bryant addressed the Board with safety issues regarding this application. Deputy County Attorney Andrew Hoffmeister was present at the Planning and Zoning Commission meeting but was not present at this hearing. Hoffmeister sent written correspondence to the Board in his absence. In order for all regulations to be met this preliminary plat will need to be presented to the Board of Adjustments according to the Subdivision Regulations. The hearing was closed at 11:52 A.M. Moved by Loewenstein and seconded by Dannehl to wait for final decision on this application until the Board of Adjustment has met to determine the request for variance. Upon roll call vote, the following Board members voted "Aye": Loewenstein, Dannehl, Greder, Klein, Morrow and Pierce. Absent: McMullen. Motion declared carried.
