#### **RESOLUTION 2017-30**

WHEREAS, the County purchase act provides that County Board may authorize a county employee or official to sell surplus county personal property, which is obsolete or not usable by the county having a value of less than two thousand five hundred dollar; and surplus county mobile equipment that is obsolete or not usable that has a value of less than five thousand dollars; and

WHEREAS, the property set forth in the attachment is personal property or mobile equipment of the county that is obsolete or not usable by the county; and

WHEREAS, each item set forth in the attachment is personal property that has a value of less than two thousand five hundred dollars; and

WHEREAS, each item in attachment of surplus mobile equipment that is obsolete or not usable by the county and has a value of less than five thousand dollars, and

WHEREAS, the Buffalo County Board of Commissioners desires to authorize the sale of the property as set forth in attachments NOW, BE IT RESOLVED AS FOLLOWS:

- Stephen Gaasch, Buffalo County Facilities Director, hereinafter referred to as the "Director" be hereby authorized and directed to sell the property set forth in attachment "A." Said sale has been scheduled for Saturday July 15, 2017 at 9:00 a.m. at 321 Central Avenue.
- 2. The Director shall make a written report to the County Board within thirty days after the end of the fiscal year reflecting, for each transaction, the item sold, the name and address of the purchaser, and the total amount paid by the purchase for each item, and the total amount paid by the purchaser, and the auctioneer's fee, if any.
- 3. The money generated by any such sales, less auctioneer's sales commissions, if any, shall be payable to the County Treasurer.
