Nicole and Thom Shulde were present for review of the Special Use Permit application submitted by Nicholas Moffett and Nicole and Thom Shulde for property described as part of the West Half of the Southeast Quarter located in Section 17, Township 12 North, Range 13 West of the Sixth Principal Meridian, Buffalo County, Nebraska for a campground and vendor market for the 2017 eclipse. No one else addressed the Board and Chairman McMullen closed the hearing at 9:25 A.M. Moved by Greder and seconded by Morrow to approve the Special Use Permit application with the following Resolution 2017-37. Upon roll call vote, the following Board members voted "Aye": Greder, Morrow, Brayton, Klein, Loeffelholz, Reiter and McMullen. None voted "Nay". Motion declared carried.

RESOLUTION 2017-37

WHEREAS, Nicole and Thom Shulde on behalf of Nicholas D. Moffett, Applicant, has filed for a Special Use Permit with Buffalo County Clerk and/or Zoning Administrator.

WHEREAS, one application was filed July 3, 2017 for a campground and vendor market for the August 21, 2017 eclipse to be situated on the following legal description: the West Half of the Southeast Quarter of Section 17, Township 12 North, Range 13 West of the 6th P.M., Buffalo County, Nebraska except a strip of land lying over and across the southern part of the Southeast Quarter of Section 17, Township 12 North, Range 13 West of the 6th P.M., Buffalo County, Nebraska described as follows: Beginning at the Southeast corner of said Section 17, thence westerly on the South line of the Southeast Quarter of said Section 17 a distance of 2665.6 feet to the Southwest corner of said Southeast Quarter, thence northerly on the West line of said Southeast Quarter a distance of 40.2 feet to a point; thence easterly a distance of 2665.6 feet to a point on the East line of said Southeast Quarter; thence southerly on said East line a distance of 39.0 feet to the point of beginning, containing 2.423 acres, more or less, which includes 2.024 acres, more or less, previously occupied as a public highway, the remaining 0.399 acres, more or less being the additional acreage secured in this transaction, AND EXCEPT a tract of land located in the West half of the Southeast Quarter of said Section 17, described as follows: Beginning at the Southwest corner of the Southeast Quarter of Section 17; thence North along the West line of the Southeast Quarter of Section 17 a distance of 74.96 feet, thence easterly deflecting 90° 21' 53" right for a distance of 872.24 feet; thence easterly deflecting 01°14' 44" right for a distance of 460.10 feet to the East line of said West half of the Southeast Quarter; thence southerly deflecting 88° 23' 30" right for a distance of 64.43 feet along said East line to the Southeast corner of said West half; thence westerly deflecting 90° 20' 24" right for a distance of 1332.16 feet along the South line of said West half to the point of beginning containing 2.23 acres, more or less, which includes 1.16 acres, more or less, previously occupied as public highway.

WHEREAS, on July 20, 2017 the Buffalo County Planning and Zoning Commission conducted a public hearing on such Special

Use Permit and on a 7-0 vote with 2 absent voted to forward this application to the County Commissioners with approval, and

WHEREAS, on August 8, 2017, the Buffalo County Board of Commissioners held a public hearing on this Special Use Permit

and,

WHEREAS, two exhibits are attached to the application

- 1. A copy of the rules and regulations as found on their web page.
- 2. The application of the Special Use Permit.

WHEREAS, only a simple majority is required by this Board to approve this Special Use Permit because no protests against

issuance of this permit have been filed, and

WHEREAS, the Board after public hearing and review of the Special Use application finds:

- 1. This campground and vendor market shall be approved.
- 2. The ending date of this permit shall be August 31, 2017 because this is not a long term use and primarily focuses on an upcoming eclipse of the sun event.

WHEREAS, the requested special use permit is found to be in compliance with Section 6.2 of Buffalo County's Zoning Regulations now in effect, in that if the proposed amendment, with the below stated conditions contained in this Resolution, would:

- 1. Be compatible with and similar to the use permitted in the district, and
- 2. Not be a matter which should require re-zoning of the property, and
- 3. Not be detrimental to adjacent property, and
- 4. Not tend to depreciate the value of the surrounding structures or property, and
- 5. Be compatible with the stated intended use of the district, and
- 6. Not change the character of the district, and
- 7. Be in accordance with the Comprehensive Plan.

NOW THEREFORE, BE IT RESOLVED THAT BY THE BUFFALO COUNTY BOARD OF COMMISSIONERS by a majority

vote of its members, this Board approves applicants' requested Special Use Permit, subject however to the following:

- 1. The ending date of this permit shall be August 31, 2017.
- 911 street address of facility is already in place on an existing sign on the front of the property that is located along Highway 2.
- 3. This is for a campground and vendor market for the 2017 eclipse.
- 4. The stated uses and areas of use as stated within the application together with the rules and regulations as set out in the application and website, as it is printed and attached to the application, are incorporated herein.

BE IT FURTHER RESOLVED that this Board reserves the power to revoke such special use permit for failure to comply with such terms, conditions and requirements, or take such other action as it may deem necessary to obtain compliance. If the Zoning Administrator or any two members of this Board find at any time that the terms, conditions and requirements of this special use permit have not been complied with, or that any phase thereof has not been completed within the time required under said special use permit or any amendment thereto, the Zoning Administrator or any two members of this Board find at two members of this Board shall report this fact to the County Commissioners, and thereafter this Board may conduct review of compliance by public hearing with notice given to applicant(s) and/or entity using the subject property. Following such public meeting this Board may take any action it may deem necessary to secure compliance including revocation and termination of this special use permit.

RESOLVED FURTHER that a copy of this Resolution shall be filed against the subject property as described above.

The Special Use Permit that was filed by Jason Martin and Amy Schoonoveron was formally withdrawn on August 4, 2017. The public hearing had been set for this meeting.
