HOLD HARMLESS CLAUSE

By signing an application, haulers thereby agree to indemnify and save harmless the County and Kearney Area Solid Waste Agency from and against all claims, suits, damages, costs, losses, which in all manner, accrue, result or arise out of the conduct of the haulers' business activities in collecting solid waste materials, and the hauler further agrees to comply with all the terms and conditions of the Integrated Solid Waste Management Act (Section 13-2001, et seq., Laws 1992 LB1257) and service agreement between Buffalo County and Kearney Area Solid Waste Agency dated February 2, 1993.

INSURANCE

Permit applicant shall provide to Buffalo County proof of insurance in the form of an original certificate of insurance in the amount of \$1,000,000 for general liability and automobile liability. Worker's compensation, including employer's liability, shall be carried and evidenced in such certificate with at least the following limits: \$100,000 each accident, \$500,000 policy limit, and \$100,000 each employee. Such insurances shall remain in full force and effect during the term of this agreement.

Undersigned agrees not to require or permit recyclable solid waste materials which they collect or intend to collect to be placed on right-of-way of County Roads.
