 To all to whom these presents shall come, greeting:  
 Whereas there has been deposited in the General Land Office of the United States a  
 certificate of the Register of the Land Office at Grand Island, Nebraska whereby it ap-  
 pears that, pursuant to the acts of Congress approved March 3, 1873, March 13, 1874 and  
 June 14, 1878, "To encourage the growth of timber on the western prairies," the claim  
 of Henry Baumgardner has been established and duly consummated in conformity  
 to law, for the North East quarter of Section eight in Township ten North of Range  
 sixteen West of the Sixth Principal Meridian in Nebraska, containing one hundred  
 and sixty acres, according to the official plat of the said land, returned to the  
 General Land Office by the Surveyor General:

Now know ye that there is hereby granted by the United States unto the said Henry  
 Baumgardner the tract of land above described: To have and to hold the said tract of  
 land, with its appurtenances thereto, unto the said Henry Baumgardner and to

This indenture of lease made at Cleveland in the State of Ohio, this 29th day of September in the year of our Lord one thousand eight hundred and ninety two, by and between J. L. Webster, Trustee of Cleveland, County of Cuyahoga and State of Ohio, party of the first part, and R. W. Brannhiser of Kearney, Nebraska, party of the second part. Witnesseth: That the first party hath let and leased, and hereby doth let and lease unto the second party and his heirs executors and administrators the following described piece or parcel of land, situated in the city of Kearney, County of Buffalo and State of Nebraska, and known as: Beginning at a point on the East line of Section (4) four, Town (18) eight, Range (16) sixteen West, and on the South line of a strip of land (200) two hundred feet wide, South from the centre of the Union Pacific Railway main track, thence in a line westerly parallel to and (200) two hundred feet South of the centre of said Railway (364.8) three hundred sixty four <sup>100</sup>/<sub>100</sub> feet to a point on the West line of block ninety of West Kearney, thence South on the West line of block ninety (477.63) four hundred seventy seven <sup>63</sup>/<sub>100</sub> feet to a point, thence Easterly and parallel with the centre line of said Railway (364.8) three hundred sixty four <sup>100</sup>/<sub>100</sub> feet intersecting the East line of said Section thence North on said Section line (477.63) four hundred seventy seven <sup>63</sup>/<sub>100</sub> feet to the place of beginning, containing (4) four acres of land together with all the buildings and appurtenances, machinery, tools, fixtures and appliances in and about the premises and used about the paper mill situated thereon, To have and to hold the above leased premises, unto the second party, his heirs, executors and administrators, for and during the term of three years, from and after the first day of October, A. D., One Thousand Eight Hundred and Ninety Two upon the following conditions, to wit: That said second party, his heirs, executors or administrators, shall pay or cause to be paid to the first party, his heirs, executors or administrators, rent to the amount of Six Hundred Dollars, at the expiration of each and every Six calendar months, from and after the said first day of October A. D. 1892, until the expiration of this lease, together with all taxes and assessments of
