Certificate of the Register of the Land Office at Grand Island Nebraska, whereby it appears that, pursuant to the act of Congress, approved 20th May, 1862, "To secure homesteads to actual settlers on the public domain," and the acts supplemental thereto, the claim of Frank Kenney has been established and duly consummated in conformity to law, for the north west-quarter of section thirty four in Township ten north of Range seventh west of the Sixth Principal meridian in Nebraska containing one hundred and sixty acres

according to the Official Plat of the survey of the said land, returned to the General Land Office by the Surveyor General:

Now Know Ye, That there is therefore granted by the United States unto the said Frank Kenney the tract of land above described, to have and to hold the said tract of land, with the appurtenances thereof, unto the said Frank Kenney and to his heirs and assigns forever.

Now Know Ye that the United States of America in consideration of the premises and in compliance with the several acts of Congress in such case made and provided have given and granted and by these presents do give and grant unto the said Frank Bacon and to his heirs the said tract - now described to him and to his heirs together with all the rights thereto appurtenant and appertaining according to the Official Plat of the survey of the said land, returned to the General Land Office by the Surveyor General:
