Atwood has been established and duly consummated in conformity to law, for the south half of the North East Quarter of Section eighteen in Township ten of Range sixteen west, in the district of lands subject to sale at Grand Island Nebraska containing eighty acres

according to the Official Plat of the survey of the said land, returned to the General Land Office by the Surveyor General:

Now Know Ye, That there is therefore granted by the United States unto the said Silas S. Atwood the tract of land above described, to have and to hold the said tract of land, with the appurtenances thereof, unto the said Silas S. Atwood and to his heirs and assigns forever.

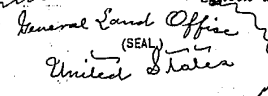

Whereas, there has been deposited in the General Land Office of the United States a Certificate of the Register of the Land Office at Grand Island Nebraska whereby it appears that, pursuant to the Act of Congress, approved 20th May, 1862, "To secure homesteads to actual settlers on the public domain," and the acts supplemental thereto, the claim of Rhoda Breed has been established and duly consummated in conformity to law, for the south half of the South East Quarter of Section Eight in Township Nine North, of Range Fifteen West, in the district of lands subject to sale at Grand Island Nebraska containing eighty acres, according to the Official Plat of the Survey of the said lands returned to the General Land Office by the Surveyor General, which said tract has been purchased by the said Rhoda Breed. Now, Know ye, that the United States of America, in consideration of the premises, and in conformity with the several Acts of Congress in such case made and provided, have given and granted, and by these presents do give and grant, unto the said Rhoda Breed and to her heirs, the said tract above described, to have and to hold the same, together with all the rights, privileges, immunities and appurtenances of whatsoever nature, thenceunto belonging, unto the said Rhoda Breed and to her heirs and assigns forever according to the Official Plat of the survey of the said land, returned to the General Land Office by the Surveyor General.

Now Know Ye, That there is therefore granted by the United States unto the said Rhoda Breed the tract of land above described, to have and to hold the said tract of land, with the appurtenances thereof, unto the said Rhoda Breed and to her heirs and assigns forever.
