 County, Wisconsin has deposited in the General Land  
 Office of the United States a Certificate of the Register of  
 the Land Office at Grand Island Wisconsin whereby it  
 appears that Full Payment has been made by the said  
 Asahel Eddy according to the provisions of the act  
 of Congress of the 24<sup>th</sup> of April 1820 entitled An act  
 making further provision for the sale of the Public  
 Lands and the acts supplemental thereto for the  
 north half of the south east quarter and the lots  
 numbered three and four of section thirty five  
 in Township nine north of Range fourteen west  
 of the sixth Principal Meridian in Wisconsin containing  
 one hundred and thirty six acres and ninety  
 hundredths of an acre according to the official plat  
 of the survey of the said lands returned to the General  
 Land Office by the surveyor General which said  
 Tract has been purchased by the said Asahel  
 Eddy Now know ye That the United States of  
 America in consideration of the premises and in  
 conformity with the several Acts of Congress in such  
 cases made and to his heirs the said Tract above
