Whereas, there has been deposited in the General Land Office of the United States a Certificate of the Register of the Land Office at Grand Island, Nebraska, whereby it appears that, pursuant to the act of Congress, approved 20th May, 1862, "To secure homesteads to actual settlers on the public domain," and the acts supplemental thereto, the claim of John Wesley Keel is the promoter of the said act supplemental thereto, the claim of John Wesley Keel of Congress of the 24th of April 1870 entitled An Act - whereby it has been established and duly consummated in conformity to law, for the grant provisions for the sale of Public Land and the acts supplemental thereto for the lot - number seven (7) of section ten, and the lots numbered four (4) and five (5) of section eleven (11) in Township Eight north of Range fourteen west of the sixth Principal meridian in Nebraska containing one hundred and seven acres and nearly hundredth of an acre now known as the United States of America in consideration of the premises and in conformity with the several acts of Congress in such case made and provided has been given and is hereby presented do give and grant unto the said John Wesley Keel and his heirs the said tract upon the described to have and to hold the same together with all the rights privileges immunities and appurtenances to according to the Official Plat of the survey of the said land, returned to the General Land Office by the Surveyor General: which said whenever has been returned and the said John Wesley Keel has been granted by the United States unto the said tract has been purchased by the tract of land above described, to have and to hold the said tract of land, with the appurtenances thereof, unto the said John Wesley Keel and to his heirs and assigns forever.
