The United States of America, To all to whom these presents shall come, Greeting:

Whereas, James Halpin of Buffalo County, Nebraska, has deposited in the General Land Office of the United States a certificate of the Register of the land office at Grand Island, Nebraska, whereby it appears that full payment has been made by the said James Halpin according to the provisions of the act of Congress of the 24th of April 1820, entitled, "An act making further provisions for the sale of the Public Lands" and the acts supplemental thereto, for the South-half of the North East quarter of Section eight and the West half of the North-West quarter of Section nine in Township twelve North of Range Sixteen West of the Sixth Principal Meridian in Nebraska, containing one hundred & sixty acres according to the official plat of the survey of the said lands, returned to the General Land office by the surveyor General, which said tract has been purchased by the said James Halpin.

Now know ye, That the United States of America in consideration of the premises, and in conformity with the several acts of Congress in such case made and provided, have given & granted and by these presents do give and grant unto the said James Halpin and to his heirs, the said tract above described; To have and to hold the same, together with all the rights, privileges, immunities, and appurtenances, of whatsoever nature thereunto belonging, unto the said James Halpin and to his heirs and assigns forever.

In testimony whereof, I Benjamin Harrison President of the United States of America, have caused these letters to be made patent, and the seal of the General Land office to be hereunto affixed.
