NEW FIREARMS PURCHASE PERMIT PROCEDURES

All Nebraskans have an important role to play in stopping the spread of COVID-19 and saving lives. To ensure the welfare of the public and our employees, we prefer to accept handgun purchase certificate applications via U.S. mail. Instructions for submitting an application are as follows:

- 1. You must be 21 years of age or older to submit an application.
- 2. Carefully read and complete the application. If there are any questions that do not apply to you please place a N/A in the box. Have it notarized on the second page of the application.
- 3. Mail the completed application with a photocopy of your Nebraska Driver's License/ State ID / permanent resident card with your current address, and \$5.00 fee (no checks) payable to:
