The in-house Inmates population on the first day of the onsite review was 140. All reasonable efforts were made to conduct the required number of targeted Inmates interviews. The auditor selected additional Inmates from the available targeted populations and increased the number of random Inmates interviews to ensure that the appropriate numbers of Inmates were interviewed. There was a total of 20 formal Inmates interviews conducted. The auditor selected Inmates randomly by using a full roster provided at the beginning of the on-site review. Interviews were conducted with at least one Inmates for each living area of the facility.</p>

which includes a review of blind spots within the facility. The information is used to determine where additional supervision is necessary, where supervisory coverage is necessary and where additional cameras may be needed. The BCJ requires supervisors to visit each housing unit once per shift.

(a) The BCJ is responsible for investigating allegations of sexual abuse and does follow a uniform evidence protocol that maximizes the potential for obtaining usable physical evidence however all criminal investigations are referred to the Buffalo County Sheriff's Office (BCSO) to investigate. BCJ staff and BCSO work together but the agency responsible for the criminal investigation is BCSO. BCJ administrative staff is responsible for the administrative proceedings. Interviews with random staff demonstrated that they have been trained in their responsibilities to preserve evidence, the collection of evidence and the chain of custody.

(b) The protocol developed is appropriate for youth; however the BCJ does not house youthful offenders therefore this provision is Not Applicable.

(c) The BCJ offers all victims of sexual abuse access to forensic medical examinations, whether on-site or at an outside facility, without financial cost, where evidentiary or medically appropriate. Interviews with the PREA Coordinator and Medical staff reiterated that all victims of sexual abuse are offered access to forensic examinations. The forensic medical examinations are referred to CHI Health Good Samaritan. The examinations are performed by Sexual Assault Forensic Examiners (SAFEs) or Sexual Assault Nurse Examiners (SANEs) and the BCJ informs the hospital prior to the inmate's arrival of the services required.

The victim advocate will also provide emotional support, crisis intervention, information, and referrals.

The staff was able to clearly articulate during the interviews the importance of keeping the information confidential.
 - (c) The BCJ does not have in house medical or mental health staff. However, the BCJ has provided information to community health providers to inform inmates of the practitioner's duty to report, and the limitations of confidentiality, at the initiation of services
 - (d) The BCJ does not house inmates under the age of 18, if the victim is considered a vulnerable adult staff must report the allegation to the designated State or local services agency under applicable mandatory reporting laws
