### Approval of Minutes-

The minutes of the May 14, 2024 meeting were previously provided to the Committee members for their review. Moved by Harpst and seconded by Bock to accept the May 14, 2024 minutes. Upon roll call vote, the motion passed unanimously.

#### Regular Agenda-

Veteran's Service Officer Starkey reviewed the limits for County Veterans' Aid for Funeral Expenses for eligible veterans. Moved by Bock and seconded by Brodine to approve County Veterans' Aid for Funeral Expenses limits of \$5,000. Upon roll call vote, the motion passed unanimously.

Veteran's Service Officer Starkey reviewed the limits for County Veterans' Aid for Burial Expenses for eligible veterans. Moved by Harpst and seconded by Mitchell to approve County Veterans' Aid for Burial Expenses limits of \$1,400. Upon roll call vote, the motion passed unanimously.

Veteran's Service Officer Starkey presented the application for Veteran T.V. to the Committee and discussed the request for \$5,000.00 for burial costs, \$1,250 for rent and

\$1,400 for expenses. After discussion it was moved by Harpst and seconded by Bock to approve the requested amount of \$5,000.00 for burial costs, \$1,250 for rent. Upon vote, the motion passed.

Veteran's Service Officer Starkey presented the application for Veteran R.L. to the Committee and discussed the request for \$1,080.00 for rent. Moved by Bock and seconded by Mitchell to approve the requested amount. Upon vote, the motion passed.

Veteran's Service Officer Starkey presented an update. Starkey stated that during his budget hearing he requested an increase from the County Board of Commissioners for the next budget year.

## Mileage Claims-

The Committee was informed that mileage claims could be submitted for those committee members requesting reimbursement.
