Also in attendance were Commissioner Myron Kouba and Veteran's Service Officer Matthew Starkey, Veteran's Service Officer Kollin Forney, Veteran Office Manager Linda Jones, Buffalo County Office Clerk Katie VanSlyke and Buffalo County Clerk Heather Christensen.

Approval of Minutes-

The minutes of the March 11, 2025 meeting were previously provided to the committee members for their review. Moved by Brodine and seconded by Bock to accept the March 11, 2025 minutes. Absent: McCoy. Upon vote, the motion passed.

Regular Agenda-

Veteran's Service Officer Starkey reviewed a request for aid for Veteran D.H. to the Committee and discussed the request for a total of \$2,793.72 (rent, insurance and dental). After discussion it was moved by Bock and seconded by Mitchell to approve the requested amount with an additional \$1,051.72 for a total of \$3,845.44 (rent, insurance and dental). Absent: McCoy. Upon vote, the motion passed.

The Veteran Committee asked County Veteran Service Officer Forney a series of questions regarding his recent training. County Veteran Service Officer Forney answered each question, discussion occurred.

County Veteran Service Officer Starkey shared a handout with the Committee that listed some of the statutes and costs associated with the metal flag holder markers for Veteran burial grave sites. Starkey pointed out the difficulty of marking newer graves with markers due to the many currently overlapping wars. Starkey requested the committee to decide how they would like to proceed with the metal markers on the graves in Buffalo County. After discussion it was moved by Bock and seconded by Mitchell to continue this agenda item to the May 13, 2025 meeting. Absent: Brodine and McCoy. Upon vote, the motion passed.

Discussion occurred regarding the recommendation for location for the June 2025 Veteran meeting. County Veteran Service Officer Starkey with call and confirm location availability and report back on the May 13, 2025 Veteran meeting.

County Veteran Service Officer Starkey shared an office update. Discussion occurred.
