JOB DESCRIPTION

POSITION TITLE: Sprayer

DEPARTMENT: Weed Department

REPORTS TO: Weed Superintendent

Purpose of Position:

Responsible for spraying noxious weeds and maintaining all equipment

Essential Functions

• Mix chemicals safely and efficiently

- Operate all spraying equipment safely and efficiently
- Maintain all equipment that has been assigned
- Create spray tickets for each customer
- Keep detailed log books of all spraying activities
- Any other duties as assigned

Marginal Functions

- On a seasonal basis, mow the yards
- On a seasonal basis, help the Highway Department cut trees
- As needed, conduct weed inspections

Essential Knowledge, Experience, and Abilities

- With the approval of the Weed Superintendent, have the ability to make some decision that affect the weed department
- Ability to follow written or oral instructions from the Weed Superintendent, other office personnel, other county employees, and the public
- Ability to keep accurate detailed log books of all spraying activities.
- Ability to keep records up to date for all roadside, bridge, and pasture spraying
- Ability to interpret the log books and transfer any information to spray tickets for each customer
- Thorough knowledge of problem solving, mechanical, mathematics, communication and time management
- Thorough knowledge of spraying chemicals, chemical mixing, and weed identification
- Ability to operate and maintain spray pickups and ATV's
- Ability to work well with other employees and other departments
- Ability to communicate effectively with landowners
- Ability to make good judgement when/if weather conditions change
- In the absence of the Weed Superintendent, have the ability to determine whether the department should spray or not

Essential Education, Certifications, and/or Licenses

- High school diploma or GED is required
- Strong mathematical and mechanical skills are a plus
- Must obtain a commercial applicators license with at least Ag Plant, Aquatic, and Right
 of Way categories in a specific time frame as determined by the County
- Experience in using spray pickups and ATV's and weed identification are highly recommended

Essential Physical Demands and Typical Working Conditions

- Must be able to carry, stand, drive, kneel, speak, squat, hear, climb, walk, sit, reach, and pull on a regular basis
- Must be able to stand or walk for an entire day.
- Must be able to lift up to 50 pounds unassisted
- May be exposed to fumes, hazards, dirt, heat/cold, chemicals, noise and toxins
- Must have regular attendance
- Must be punctual
- Must have the ability to work overtime when necessary
- Must have the ability to work at the job side
- Must have the ability to travel
- May work indoors or outdoors in any type of weather
